**TREASURER'S REPORT:** Chuck Keistler presented the Treasurer's Report for the month of November as printed in the December business meeting minutes. As of today our mortgage balance is \$27,513.59, which was reduced by \$4,736.93 last month, and the budget checking balance is \$67,823,87. Motion to approve by Paul Sauls and seconded by Roy Emond. **APPROVED** by show of hands.

**OLD BUSINESS:** None.

**NEW BUSINESS: Finance Committee:** Gean Ann Emond presented a recommendation from the Finance Committee regarding ministerial allowances for 2020. This recommendation does not require a vote by the church. This is for

housing allowances that have to be recorded in the church business meeting minutes prior to the year when the new salaries take place. We need to record the housing allowances for Dick Hammer, whose allowance amount for the year 2020 is \$15,344.88, and Chris Larsen's allowance amount is \$16,800.00. Those are amounts set by those two gentlemen. It is their choice to do that. We are just merely recording those amounts in the minutes of the meeting.

Gean said that we are a trusting congregation because we have had an audit review which was worked on before she became a part of the Finance Committee for the years of 2017 and 2018. The resulting audit entries that the CPA made for that audit review actually put three of our designated accounts into negative balances, Nobody has asked about that at all. Those accounts will not be negative when we get to the end of December. We need to cover those. Cami is going to go back to those years and see if we can trace back to how that happened. Whatever the auditor found that he felt like he should have made those adjustments for, we can rectify through the records. Or, if that is not the case, then we have to cover these balances in these designated accounts. The Finance Committee discussed this in their meeting last Wednesday night. The amount is \$546.57 that we need in total. We were going to take that out of the Capital Escrow Building Fund. There is more money there than we thought that we needed to set aside. There will be another transfer there in December. We are going to take care of that before December I don't think that is going to hurt that balance if we can't get it back, based on the old entries in 2017 and 2018, I just wanted to let you know that we, have been watching that and we are going to take care of that before December.

**Deacons/Yokefellows:** Mark McCraney recommended that since a lot of people will be out of town that the Sunday, December 29<sup>th</sup> service be canceled. Motion to approve by Roy Emond and seconded by Tony McFarlane. **APROVED** by show of hands.

ANNOUNCEMENTS: Roy Emond announced that on Saturday. January 11th there will be a morning deacons meeting with the prospective pastor, candidate. Then at 4:00pm that afternoon there will be a church question/answer session with the candidate. Sunday, January 12<sup>th</sup> there will be the usual called worship service. At the end of the worship service, there will be a Special Called business meeting at which there will be a secret ballot vote as called for in our church documents. Chuck Keistler, Chairman of the Constitution, Bylaws, and Policies and Procedures Committee explained that Roy's Committee, the Pastoral Search Committee, is following the church Bylaws. They are following the required steps of the church Bylaws, which requires the affirmation of by the church for the call offered to the candidate from the Pastor Search Committee. The Pastors Search Committee will prepare the secret ballot to be used for the vote. The Pastors Search Committee also prepared the hiring package to be presented to the
