Bids came back as follows: Wright Co. \$162,500; Simpco Services \$120K. (These were one (1) page quotes.) Another bid was received from WDR, a mechanical contractor, at \$132K. (They sent a booklet.) WDR estimates, by working Monday—Thursday it would take 2—3 weeks to install. Obtaining this contractor would cost an additional \$70K. Recommendation is to obtain the 3rd bidder (WDR). Money will come from the CDs, which have a balance of \$671,631.53 as listed on the Financial Summary page of these minutes. - B. Refresh Ad Hoc Committee update presented by Dallas Hansen. Monday all the pews in the balcony were removed. Took about two and half (2.5) to three (3) hours. On February 5, 2024 the pews downstairs will be removed. A call for volunteers was made for this project. It was announced Mary Ann Winstead will be Dallas' assistant. Electrical work will be done on February 19th; lighting February 26th and carpet installed March 4, 2024.
